**RESOLUTION NO. 22-8-1**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EUFAULA, OKLAHOMA WHEREBY THE COUNCIL OF THE CITY OF EUFAULA RESOLVES TO PLACE BEFORE THE ELECTORATE OF THE CITY OF EUFAULA, OKLAHOMA THE QUESTION, TO-WIT: "SHALL THE CITY OF EUFAULA, OKLAHOMA, CHANGE ITS FORM OF GOVERNMENT FROM THE STATUTORY COUNCIL-MANAGER FORM OF GOVERNMENT TO THAT OF THE STATUTORY ALDERMANIC FORM OF GOVERNMENT".**

**WHEREAS**, the Council Members of the City of Eufaula met on the \_\_\_\_ day of August, 2022, in special session.

**WHEREAS**, a quorum of the Council was present; the Motion was duly made and duly seconded to place before the electorate of the City of Eufaula, Oklahoma the question, to-wit:

"Shall the City of Eufaula, Oklahoma, change its form of Government from the statutory Council-Manager form of Government to that of the statutory Aldermanic form of Government."

**WHEREAS**, the majority of the Council voted "yes" for presenting the question to the electorate of the City of Eufaula, Oklahoma.

**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:**

1. That an election be set for the electorate of the City of Eufaula, Oklahoma on the 8<sup>th</sup> day of November, 2022 to determine whether or not the form of City Government shall be changed from the Statutory Council-Manager to that of the statutory Aldermanic form of Government.
2. That an Order be issued to present the question to the electorate of the City of Eufaula, Oklahoma.
3. That said election shall be held on the 8<sup>th</sup> day of November, 2022 designated polling locations from the hours of 7:00 AM to 7:00 PM

**BE IT FURTHER RESOLVED** that precinct 314 will be closed for the November 8, 2022 election for the reason no persons are residing in precinct 314.
